I acknowledge and agree that the Utilities makes no representation as to the safety, reliability an/or efficiency of the Measures. The Utilities makes no warranty, whether express or implied, including warranty of merchantability or fitness for any particular purpose, use or application of the Measures.

I acknowledge and agree that Utilities shall not be liable for any damages or losses arising out of any act or omission of Contractor or any subcontractor of Contractor in performing the Work, and I hereby waive any and all claims against the Utilities that may arise in connection with the Work. I agree to hold the Contractor solely responsible for the performance of the Work and for any and all claims, losses, liabilities, damage and expenses (including attorneys' fees and costs) that may incur as a result of Work. Furthermore, I shall defend, indemnify, and hold harmless Utilities and its officers and employees against any and all causes of action, liabilities, damages, demands or costs, for injury to or death of any and all persons whatsoever, and for any and all damage to property, in any manner arising from, or in connection with, the performance of the Work hereunder, except for those damages caused solely by the negligence or willful misconduct of Utilities. I acknowledge and agree that the Utilities shall not be liable if the current or future tenant removes any or all of the installed Measures, including appliances, without my prior consent.
